



Community Foundation of St. Clair County	Stimulating public/private partnership - Just before Christmas, 2011, our Foundation was gifted ownership of almost one-mile of St. Clair River shoreline in Port Huron. This impressive gift came from our good friend and philanthropist, James C. Acheson. He was willing to make the gift to the Foundation providing that we would ensure public access in perpetuity and create a new plan to enhance access to the waterfront for recreation and tourism. The discussions and planning in preparation for this gift began in the 3rd quarter of 2010 and lasted for more than a year. Through the work of numerous consultants and other partnering organizations, our foundation facilitated public workshops and forums which led to the creation of a new community master plan for this stretch of shoreline. Project components include a multi-purpose pedestrian trail, fishing pier, restored railroad ferry dock, outdoor classroom and new plant and wildlife habitat along the entire shoreline. With the plan and partners in place, the Foundation began seeking public and private funding to cover the projected costs of \$3.6m+ needed to create the new Blue Water River Walk. The Foundation had planned on this project taking anywhere from 6 â 10 years to complete after we began in 2010. Incredibly, especially in this economy, the Foundation and our partners have secured funding and/or pledges of more than \$3 million already, and we now expect to complete the project in 2014.
Community Foundation of the Holland/Zeeland Area	Leveraging or brokering funds to meet community needs - CFHZ served as the grantee and fiscal sponsor and received close to \$400,000 from W.K. Kellogg Foundation to fund and grow the Ready for School Education initiative. We also leveraged local corporate and individual gifts dollars with foundation matches to launch Destination Education - a community catalytic effort with support from the National and Michigan College Access Network, CFM and the Kresge Foundation.
Community Foundation of the Upper Peninsula	Providing technical assistance to nonprofits - Our financial hub service provides back office support to small foundations throughout Michigan.
Four County Community Foundation	Stimulating public/private partnership - We granted funds for Double Up Food Bucks which doubles the purchases for locally grown fruits & vegetables at local Farmers Markets. Families who use the Bridge Card and local farmers both benefit from the partnership of public & private funding.

The outcome was a five-year transformation plan leading to efficiency improvements, cost savings, and service model improvements.
